

**HORSHAM DISTRICT COUNCIL**  
**(OFF-STREET PARKING PLACES)**  
**(CONSOLIDATION) ORDER 2023 (Amendment No. 5) ORDER 2024**

Horsham District Council in exercise of its powers under Section 32, 33 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, hereby makes the following Order:

1. This Order is supplemental to the Horsham District Council (Off-Street Parking Places) (Consolidation) Order 2023, as amended by:
  - the Horsham District Council (Off-Street Parking Places) (Consolidation) Order 2023 (Amendment No.1) Order 2023;
  - the Horsham District Council (Off-Street Parking Places) (Consolidation) Order 2023 (Amendment No.2) Order 2024;
  - the Horsham District Council (Off-Street Parking Places) (Consolidation) Order 2023 (Amendment No.3) Order 2024; and
  - the Horsham District Council (Off-Street Parking Places) (Consolidation) Order 2023 (Amendment No.4) Order 2024.
2. This amendment relates to Burstow Court car parking areas, Bishopric, Horsham, West Sussex.
3. The Horsham District Council (Off-Street Parking Places) (Consolidation) Order 2023, as amended, shall have effect and shall be read as if the Schedule 1, the Schedule 4, the Schedule 5 and the Schedule 6 attached to such Order relate to the Burstow Court parking areas and were substituted with the Schedules 1, 4, 5 and 6 incorporated to this Order.
4. This Order shall come into operation on 8<sup>th</sup> August 2024 and may be cited as the Horsham District Council (Off-Street Parking Places) (Consolidation) Order 2023 (Amendment No.5) Order 2024.

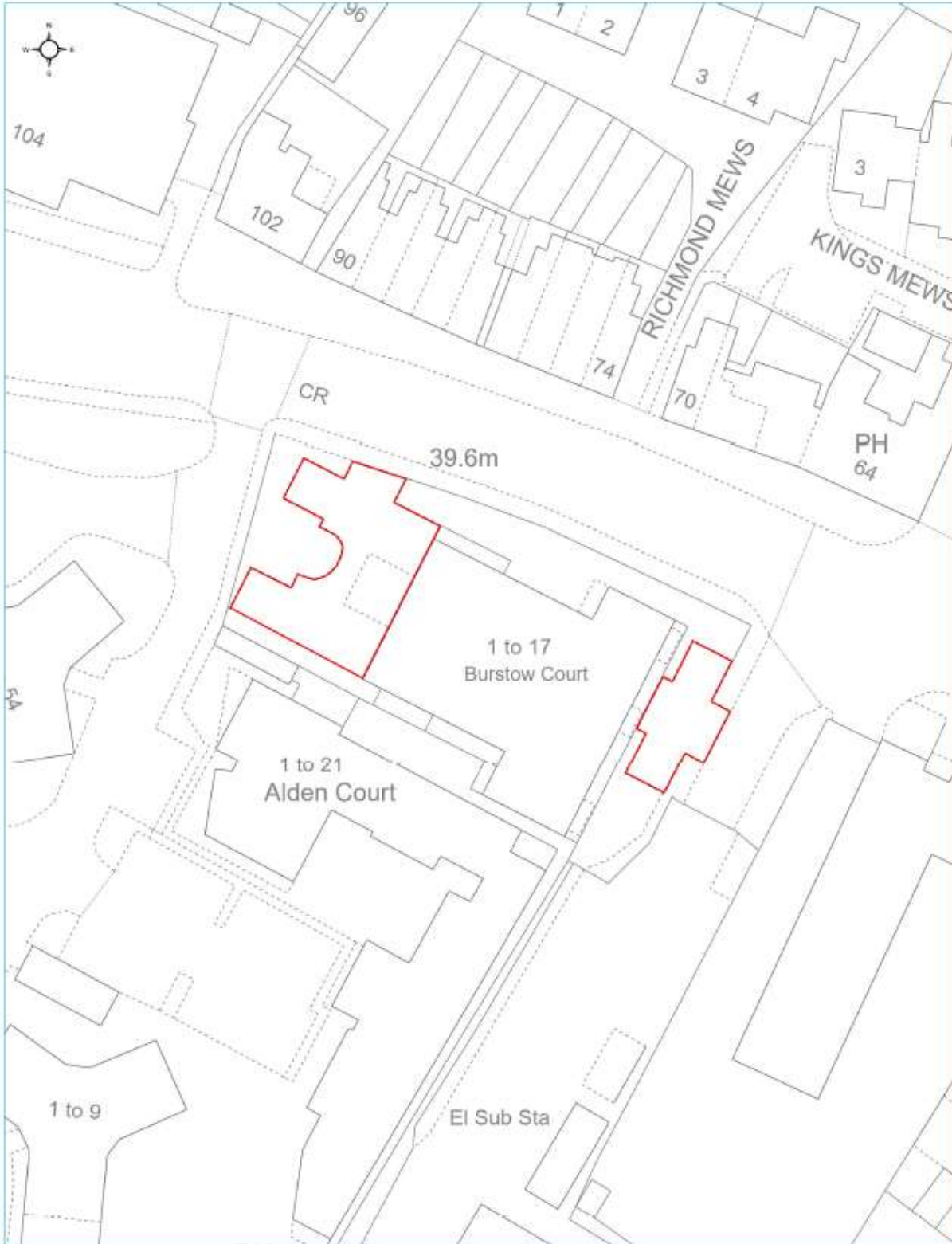
