Examination of the Horsham Local Plan 2023 -2040

I am writing to you because you have made representations concerning the Horsham Local Plan 2023 -2040 published by the Local Planning Authority under Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended).

I have been appointed as the independent Programme Officer to assist the Inspector with all administrative aspects of the examination and my contact details are set out below. Outside of the hearing sessions which form part of the examination, the Inspector does not have direct contact with either the Local Planning Authority or Representors. Therefore, all communications with the Inspector will need to take place through me.

The Inspector is currently appraising the Plan, the associated evidence and the representations submitted at the Regulation 19 stage, and I will be in contact again when I am able to provide further information on the examination process, including the timing of any hearing sessions. This might not be for a number of weeks.
